Without state aid to education and state revenue sharing, your tax bill would have been 7.4% higher. Interest of 5.00% will be charged after 10/02/2017 and 04/02/2018.
As of April 1, 2017 the Town of Newcastle does not have any outstanding bonded indebtedness

Per state law the ownership and valuation of all real and personal property subject to taxation shall be effective as of April 1st. If you have sold your property after April 1st, 2016, it is your responsibility to forward this bill to the current owner.
